A Border Patrol Agent determined the subject had unlawfully entered the United States from Mexico, at a time and place other than as designated by the Secretary of the Department of Homeland Security of the United States. After determining that the subject was an alien whom illegally entered the United States, the subject was arrested and transported to the McAllen Border Patrol Station for further processing.  <b>IMMIGRATION/CRIMINAL VIOLATION:</b> At the McAllen Border Patrol Station, the subject was asked if they wanted to make a Sworn Statement as part of the Expedited Removal Proceedings. Service Form I-867 A/B was read and explained to the subject. The subject understood and was willing to answer questions and give a statement. The subject again stated they are a citizen and national of El Salvador without the necessary legal documents to enter, pass through, or remain in the United States. The subject also admitted to illegally crossing the international boundary without being inspected by an Immigration Officer at a designated Port of Entry.  <b>CONSULAR NOTIFICATION:</b> The subject was notified of the right to communicate with a consular officer from their country as per Article 36(a) (b) of the Vienna Convention of Consular Relations. The subject acknowledged understanding the right and declined to speak with someone at this time. The subject further stated they do fear persecution or torture if returned to their country of citizenship.  <b>DISPOSITION:</b> The subject is being processed for Expedited Removal.
